- The terms of reference of the Andhra Pradesh State Goshala Development Committee are as follows:
  - To advise the State Government on measures to establish and strengthening the Goshalas economically and for all-round development of Goshalas;

b) To take all steps for amelioration of cows and other animals by encouraging the construction of sheds, water troughs and the like by providing for Veterinary assistance to the uncared cows and other animals;

c) To encourage the formation or establishment of Pinjarapoles, rescue homes, animals shelters and the like where cows and other animals may find a shelter when they have become old and useless or when they need protection;

d) To cooperate and coordinate with the Associations or Bodies established for the purpose of preventing the unnecessary pain or suffering of uncared and old cows and other animals; and

- e) To take all steps for creating awareness among the farmers to preserve and protect the cows and other animals in their own interest and for agriculture purpose;
- 3. The Director of Animal Husbandry will be the Convener of the Committee. The term of the said Committee shall be for a period of three years from the date of issue of this order. The Andhra Pradesh State Goshala Development Committee will meet at least twice in a year and form its own regulations regarding conduct of the meetings etc.
- 4. The funds of the Andhra Pradesh State Goshala Development Committee shall consists of contributions, donations, subscriptions, bequest, gifts and the like made to it by any local authority or by any other person/agencies/organizations.
- 5. The Committee shall be treated as first class Committee for purpose of drawl of T.A. and D.A. by the non-official Members of the Committee. The non-official Members of the Committee shall be allowed T.A. and D.A. as per the orders issued in G.O.Ms.No. 115, Finance & Planning (F.A.) Department, dated 16.4.1979 read with G.O.Ms.No. 125, Finance & Planning (FA) Department, dated 16.4.1982 The Director of Animal Husbandry will be the Controlling Officer for purpose of counter signature of the T.A. Bills of the non-official Members of the Committee.
- 6. As, the economy orders of the Government do not permit the Grade-I officers of Government to undertake journeys by air, the non-official members also are not entitled to air travel as well as by air conditioned 1<sup>st</sup> Class on Railways. The non-official Members are entitled for sitting allowance of Rs.100/- each for attending the meetings.
- The expenditure shall be debited to "2403 Animal Husbandry 01 –Direction and Administration SH
   Headquarters Office 110 Domestic Travel Expenses 111 Traveling Allowance".
- The office of the Committee shall be located in the office of the Director of Animal Husbandry, Andhra Pradesh, Hyderabad. The Director of Animal Husbandry, Hyderabad shall provide Secretarial assistance to the Committee as and when required.
